1. Subject matter

The artist commits to advertising the product and the name of Agner Swissdrumsticks for the duration of this agreement. Agner Swissdrumsticks is allowed to use in standard ways the name, the present or future stage name of the artist for promotional purposes for the duration of this agreement. See details under point 2.

2. Advertising/promotion

For the duration of this agreement, the artist to make himself available to Agner Swissdrumsticks for photo and video shootings, public events, interviews and autograph sessions, all by appointment.

Agner Swissdrumsticks has the right to use the products and results, which are specified above, for promotional purposes: photos, video recordings, and other recordings made under the conditions of point 2. Agner Swissdrumsticks has the right to use the name of the artist in (specified) magazines, broadcastings, television, internet and other, especially not yet established or created, forms of media.

Documents, photos, videos and other works done in collaboration with Agner Swissdrumsticks are at the company's absolute disposal, even over the contract period and are considered a property of Agner Swissdrumsticks.

3. Exclusivity

The artist commits to using solely Agner drumsticks and to publicly presenting the products of Agner Swissdrumsticks in the best possible way. The artist commits to independently arrange the advertising opportunities mentioned in the application form and to complying with the information he has given. Should this not be possible, the artists commits to informing Agner Swissdrumsticks immediately.

4. Flow of Information

The artist commits to informing Agner Swissdrumsticks about any change of address, tour dates and any appearances immediately. This applies for any appearance on stage, with or without the artists original band.

5. Entrances

For any appearance of the artist, as a solo artist or in collaboration with a band, Agner Swissdrumsticks has the right to request VIP entrance passes in advance by phone or in writing and to obtain them free of charge.

6. Terms of payment

Non-compliance of dates of payment and/or non-payment of endorsement-deliveries can guide to an annulment of the endorsement.

7. Duration of collaboration

The unlimited collaboration begins as soon as Agner Swissdrumsticks is in possession of this application form, has proposed a deal to the artist, and deal has been accepted by the artist. The collaboration can be cancelled by both parties in writing at any time. Arrangements made before the date of cancelation are to be observed by both parties.

8. Final provisions

In the absence of any other agreement with Agner Swissdrumsticks, under any circumstances the artist must not sell drumsticks received by Agner Swissdrumsticks to third parties, nor is he allowed to enrich himself in any way possible with the given drumsticks. In case of an abuse of these provisions, the collaboration is cancelled and any special deals expire immediately.
